

Privacy Policy

Super Six Sports Gaming Pvt Ltd, its affiliates and group companies (“Company”, “we”, “us”), we are committed to respecting the privacy rights of all visitors/users of our website: www.fantopark.com (“Website”). Through the Website, the Company offers customized sports experiences including but not limited to travel packages for sports events across the world, live and virtual interaction with sports personalities. The experiences shall collectively be referred to as the services (“Services”) for the purposes of this Privacy Policy.

Please note that this Privacy Policy (“Policy”) only applies to the users of the Website and the information and data gathered on the Website and not to any other information or website. You are hereby advised to read this Policy carefully and fully understand the nature and purpose of gathering and/or collecting any sensitive, personal and other information and the usage, disclosure and sharing of such information. By viewing or accessing the Website or by requesting any Services through the Website, you hereby also give your consent to the Company sharing information with (a) its affiliates and group entities to enable them to reach out to You in relation to the products and services offered by them; and (b) third party service providers in relation to Company’s operations and transfer and/or storage of Personal Information and data across borders.

1. This Policy explains:

- ◆ The information we may collect about you online.
- ◆ The use and role of cookies and similar technologies on our website.
- ◆ How we will protect and use information we collect about and from you.
- ◆ The circumstances in which we might disclose your details to anyone else.
- ◆ When we may use your details to contact you; and
- ◆ How you can be sure the information we hold about you is accurate and current.



2. Information Gathered

In general, you can visit our website without revealing your identity or any Personal Information about yourself and the information we collect from you will vary depending upon the activity you seek to engage. We may combine demographic information with Personal Information to tailor our offerings or web pages to your preferences or interests. Other information: We may also collect some additional information and documents, including but not limited to:

- ◆ Transactional history (other than banking details) about your e-commerce activities and buying behaviour.
- ◆ You or a third party created data that you wish to store on our servers such as image files, documents, etc.
- ◆ Data available in the public domain or received from any third party including social media channels, including but not limited to personal or non-personal information from your linked social media channels (like name, email address, friend list, profile pictures or any other information that is permitted to be received as per your account settings) as a part of your account information.
- ◆ Information pertaining to any other traveller(s) for whom you make a booking through your registered account. In such a case, you must confirm and represent that each of the other traveller(s) for whom a booking has been made, has agreed to have the information shared by you disclosed to us, our affiliates and our group companies and further shared by us with the concerned third-party service provider(s).
- ◆ While you have the option not to provide us with certain personal information, withdraw your consent to collect certain information, request temporary suspension of the collection of personal information or request deletion of personal information collected, kindly note that in such an event, you may not be able to take full advantage of the entire scope of features and services offered to you and we reserve the right to restrict your access to certain areas or Services available on the Website.



3. Usage

Registration on the Website: We use the information provided by you including your Personal Information for

- ◆ Registration and creation of your account on the Website. Making a booking: While making a booking on your behalf, we may use the information provided by you.
- ◆ Including your Personal Information. We may also use the information provided by you of the travellers availing our Services along with you. Other Purpose: We, our affiliates and our group entities may also use the information provided by you.
- ◆ Including your Personal Information to provide the services which may include but is not limited to the following:
 - ◆ Confirm your reservations with respective third-party service providers.
 - ◆ Keep you informed of the transaction status.
 - ◆ - send booking confirmations.
 - ◆ - send any updates or changes to your booking(s);
 - ◆ Allow our customer service to contact you, if necessary.
- ◆ Customize the content of our website.
- ◆ Validate/authenticate your account and to prevent any misuse or abuse.
- ◆ Issuing newsletters
- ◆ To contact you upon your request, or to respond to your query.
- ◆ Reach out to you about the services offered by our affiliates and our group entities.
- ◆ Audit and research purpose: We may also use Personal Information for auditing, research and analysis, and to operate and improve our Services. In certain circumstances, we may share aggregated, non-personal information with our affiliates, our group entities and third parties.

4. Cookies and Other Tracking Technologies

Some of our web pages may also utilise “cookies” and other tracking technologies. A “cookie” is a small text file that may be used, for example, to collect information about your activity on our website. Some cookies and other technologies may serve to recall Personal Information previously indicated by you. We may also analyze information that does not include Personal Information for trends and statistics.

5. Disclosure and Sharing

For the purpose of improving your user experience, we may your information including your personal information with our affiliates, our group entities and third parties.

◆ Our Affiliates and group companies

In the interests of improving personalization and service efficiency, we may, under controlled and secure circumstances, share your Personal Information with our affiliate or group companies. This will enable them to provide you with information about various products and services offered by them.


◆ Third Party

Third parties provide certain Services available on our website and on our behalf. We may provide information, including Personal Information, to third-party service providers to help us deliver information and Services efficiently and effectively. 6. Confidentiality and Security

We will keep confidential and protect your Personal Information except where disclosure is required or permitted by law. We follow generally accepted industry standards to protect the Personal Information submitted to us, both during transmission and, once we receive it, for storage and disposal. When you enter sensitive information on our registration forms, we encrypt that information using secure socket layer technology (SSL). All information we gather is securely stored within databases controlled by us. The databases are stored on servers secured behind a firewall; access to the servers is password-protected and is strictly limited. No method of transmission over the Internet or method of electronic storage is 100% secure, however. Therefore, while we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.
